

ALL INDIA CENTRAL GOVERNMENT PENSIONERS ASSOCIATION HQ. PUNE

The meeting of the Post & Telegraphs pensioners residing in Pune & Mumbai was held on 10th August 1947 and it was decided to form a Pensioners Association by name as 'All India Posts & Telegraphs Pensioners Association, Poona' and appointed a committee to form its Constitution/ Bye-laws etc.

Due to sole organization fighting for the cause of the pensioners, other Central Govt. pensioners demanded to join the Association, Annual General Body Meeting held in 1991, decided to change the name as 'All India Central Government Pensioners Association, HQ Pune'

Considering the Network and Activities of the Association it was included in Identified Pensioners Association by DOP&PW New Delhi.

The Association was enrolled as SCOVA member on rotation from January-2012 for two terms of two years. Submitted the Memorandum of Demands to Fifth, Sixth and Seventh Central Pay Commission for consideration as recommendations.

The Association celebrated DIMOND JUBILEE (1947-2022) year of its existence to safeguard the interests of the All India Central Government Pensioners/ Pensioners of Public Sector Units and Family pensioners to strive to redress their grievances regarding pensionary benefits and related issues.

Considering our work culture, active participation during the various meeting under Chairmanship of Secretary/Joint Secretary, DOP&PW and also active participation in the Government campaigns, AICGPA Hq. Pune has been enrolled as Standing Group member of SCOVA, reconstituted vide resolution dated 26th September, 2023.

AICGPA Hq. Pune is registered under Maharashtra Society Act vide No. MAH-0938 and Public Trust Certificate No. F-753 Pune.

AIMS AND OBJECTS.

- (A) To safeguard the interests of the **All India Central Government Pensioners and Pensioners of Public Sector Units** and their dependence and to strive to redress their grievances regarding pensionary benefits and also to undertake educational, social, cultural and economic services.
- (B) To build up the strong organization of All India Central Government Pensioners and Pensioners of Public Sector Units covering the whole of India.
- (C) To issue for circulation amongst the members of the association such literature, as will keep them informed of the Government orders related to pensioners and other activities for the benefit to pensioners.

- (D) To raise funds by subscription and donations from the members and others to conduct the work of the association.
- (E) To co-operate with other associations of central and state government pensioners have similar aims.
- (F) The association shall function as a non political **and non religious** public body and shall carry on its work within the constitutional limits.
- (G) To donate funds to social organizations having charitable objects.

FRAMEWORK

- (A) **General Body:** - It shall be the supreme deciding body. It shall meet at least once a year in a meeting termed “Annual General Meeting” in which it shall adopt –
 - (1) The annual report regarding activities of the Association and of progress of work done in the year under report prepared and submitted by the Central Working Committee.
 - (2) The annual statement of accounts, submitted by the **Central** Working committee along with the report from the auditors.
 - (3) The budget for receipts and expenditure for the next **financial** year.
 - (4) It shall elect office bearers on the Central Working Committee and appoint auditors.
 - (5) Adopt resolutions furthering aims and objects of the Association and,
 - (6) Take decisions on matters it may think essential.
 - (7) To consider and adopt the resolutions with respect to the amendment of the constitution of the Charitable Society/Trust referred to it by the Managing Committee or by the members of the Charitable Society/Trust.

(B) **CENTRAL WORKING COMMITTEE(CWC):-** The Central Working Committee, comprising of maximum 17 members elected by the Annual General Meeting will consist of –
